## Cooperation and Dialogue on Migration and Mobility – Phase II

### Background

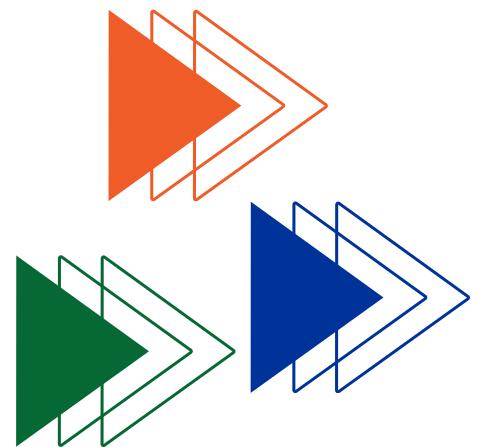
To facilitate safe, legal and orderly migration and to address challenges related to irregular migration within the EU-India migration corridor, the European Commission and the Government of India signed the Common Agenda on Migration and Mobility (CAMM) in 2016. In support of the joint objectives outlined in the CAMM, Phase I of the EU-India Cooperation and Dialogue on Migration and Mobility project was carried out from 2017 to 2022. During Phase I, 35+ government meetings, 20 knowledge products and over 40 communication products were delivered. To further deepen EU-India cooperation on migration and mobility, Phase II will be implemented from October 2023 to October 2025.

- Labour market analysis;
- Exploring the potential for skills/qualifications benchmarking and recognition in key sectors;
- Cooperation and awareness raising on preventing irregular migration;
- Improved cooperation on return and readmission procedures;
- Updates on migration and mobility trends within the EU-India corridor.

## Overall Strategy

- **Develop** a shared understanding of regular labour migration pathways as well as forms of irregular migration in the EU-India corridor;
- **Facilitate** dialogue and consultations among relevant stakeholders within the EU-India corridor;
- **Conduct** research and analysis and contribute to evidence-based migration policymaking;
- **Disseminate** information and raise awareness.

## CAMM At A Glance

- The EU-India Common Agenda for Migration and Mobility (CAMM) provides a framework for cooperation on joint objectives, recommendations and actions.
- It contains four priority areas:
  - Better organizing legal migration and fostering well-managed mobility
  - Preventing and combating irregular migration, addressing trafficking in human beings
  - Maximizing the development impact of migration and mobility
  - Promoting international protection.
