Project Overview



Strategic and Institutional Management of Migration in Libya

The action's overall objective is to support the Libyan administration at central and local levels as well as Libyan civil society and academia in their efforts to develop the necessary prerequisites for effective migration governance geared towards improving the management of migration flows and the living conditions of migrants in Libya.

The outcomes for the implementation phase defined during the inception phase together with the Libyan counterparts and the European Commission are listed below:

- 1. **To identify** the mandates and capacities of Libyan stakeholders (central and local authorities, civil society, academia.) in order to improve migration management;
- 2. To assist the Libyan administration in improving the current structures, mechanisms and procedures necessary for migration governance in line with international standards and Libyan specificities and needs;
- 3. To support Libya's reintegration into regional and international dialogues on migration.

Migration Governance Program

The action is composed of three work-streams. First, the Migration Governance Institutional Consolidation, assisting the Libyan administration in improving the current structures, mechanisms and procedures of migration governance, in line with international standards, Libyan needs, and local migration governance. Second, the Libya Migration Governance Facility (further outlined below), will enable a dynamic approach to directly assisting the Libyan authorities in responding to their specific and developing needs regarding administrative, legislative or operational questions in the field of migration via a demand-driven operational facility. Third, the development of a Migration Policy and Strategy, which will address a more long term outlook for migration governance in Libya, integrating ongoing and future activities.

The Libya Migration Governance Facility

will provide, in a flexible and fast manner, on-demand capacity building and expert technical support on migration governance. It will allow for a dynamic approach to providing support in line with changes in the context, in a forum that can complement current and emerging initiatives. The set-up of the facility will also take advantage of the lessons learnt from the joint EU-ICMPD pioneering initiative "Migration EU eXpertise" (MIEUX), thus delivering significant results.

Integrated Border Management (IBM) Activities

Within the framework of the project, ICMPD is working together with the EU Border Assistance Mission in Libya (EUBAM) and the Libyan National Team for Border Security and Management (NTBSM) on developing the . It will inform the Libyan Government about the complex issue of reforming the border security and management sector. The document will describe the current status of the border security and management system, identify the main causes of this situation and present its impact on the Libyan state and society, specifically on the internal integrated border management. It then proposes that creating an institutional and legislative framework in line with the integrated border management principles should follow reforming the border security and management in Libya.
