**ICMPD** has a long and successful history of cooperation with Georgia. It started with the participation of Georgia in regional projects and processes, such as the Budapest Process and the Prague Process, and continued with ICMPD provision of expertise in preventing and fighting trafficking in human beings, dealing with readmission and visa facilitation issues, and integrated border management. Further, ICMPD and its Georgian counterparts have cooperated in the migration management field. In September 2013, the government of Georgia and ICMPD signed the Agreement of Cooperation, which was ratified by the Georgian parliament in November 2013. This agreement further strengthened and developed cooperation between Georgia and ICMPD.

Following ratification of the agreement, as well as the grant contract for implementation of the "Enhancing Georgia's Migration Management" (ENIGMMA) project, ICMPD established an office in Tbilisi, responsible for maintaining general cooperation with Georgian migration stakeholders and implementation of the ENIGMMA project under supervision from ICMPD headquarters. The ENIGMMA project support for the Government of Georgia in implementation of the migration-related areas of the visa dialogue between the European Union and Georgia was successfully finalised in July 2017.

#### Enhancing Georgia's Migration Management (ENIGMMA)

**Objective:** The main objective of the project was to strengthen the migration governance framework in Georgia in line with the Visa Liberalisation Action Plan. The project is one of the outcomes of Georgia's continued progress in the implementation of the EU-Georgia Partnership and Cooperation Agreement, the EU-Georgia European Neighbourhood Policy (ENP) Action Plan, the Mobility Partnership and the visa facilitation and readmission agreements.
