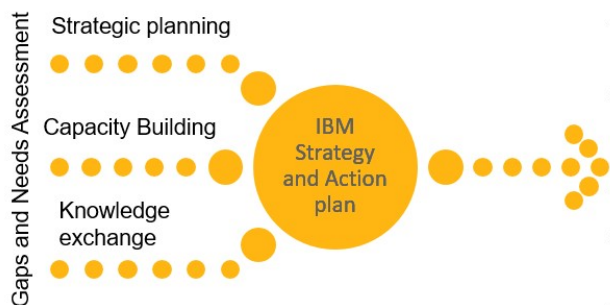
Multilevel and pluri-disciplinary approach

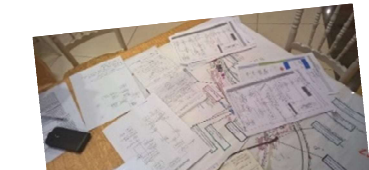

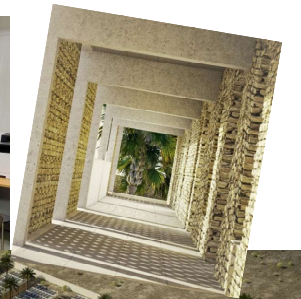

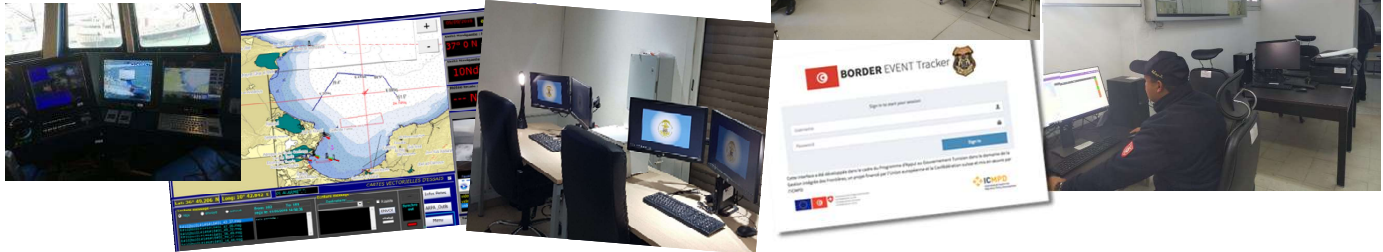

ICMPD Border Management and Security Programme in Brief

- Special BMV team established in 2003 (staff: 12 HQ, 1 BXL, 1 RCO MED + Field Offices)
- Strong focus on **Integrated Border Management**
- 2003: EC tasked to support the development of the IBM Concept for the Western Balkans (COM Working Document)
- 2009: request to prepare a “global” concept on IBM – IBM Guidelines for EC external cooperation
- Expansion: geographical division and thematic specialisation (OC, terrorism/FTF, cybercrime/security, trade, border communities, etc.)
- IBM Concept, Strategy and Action Plan development and planning for (almost) all Western Balkans countries, Armenia, Belarus, Kyrgyzstan, Lebanon, Tunisia, etc.
- Growing involvement in capacity building and operational training activities, as well as procurement.
