# COMPREHENSIVE RESILIENCE SUPPORT FOR DISPLACED PERSONS FROM UKRAINE (CORE UA)

## OVERALL OBJECTIVE



The main goal of the project is to *ensure the safe mobility of displaced Ukrainians and, at the same time, to ensure that the advisory services provided comply with the German and EU directives on the granting of temporary protection as well as other directives related to legal residence and safe return.*

**The project is funded by:** The (National) German AMIF Programme 2021-2027 and the Federal Office for Migration and Refugees (BAMF)

**Project implementation period:** 1 October 2024 - 30 September 2027

## SPECIFIC OBJECTIVES



**Support Temporary Protection Measures:** facilitate the expert exchange between EU Member States and Ukraine on the implementation and the future of temporary protection.



**Expand Advisory Services for Displaced Ukrainians:** Establish new consultation centres in Germany to provide displaced persons with vital information on legal, social and integration matters.



**Empower the Ukrainian Diaspora:** Strengthen the role of Ukrainian diaspora organisations in Germany to support the integration of displaced persons and promote sustainable return and reintegration in Ukraine.



**Enhance Migration Management in Ukraine:** Assist Ukraine in improving its migration legislation, including development of a new migration framework.

## PROJECT IMPACT



The activities under this programme will positively impact the organisation of adaptation efforts for displaced Ukrainians in Germany and facilitate preparations on the German side regarding the future of their temporary protection status, whether through legalising their stay, integrating them or enabling their safe and dignified return home.

## KEY PROJECT MEASURES



### Measure 1:

#### Expert Exchange on Temporary Protection

Facilitate professional exchanges between Germany, selected EU states and Ukraine to develop exit strategies for temporary protection.



### Measure 2:

#### Expansion of Consultation Centres

Establish two new Ukrainian Consultation Centres (UCCs) in Germany.

Consultation topics include legal advice, integration support and return/reintegration information, targeting displaced persons.

Activities also include creating a digital platform, namely videos and podcasts and awareness campaigns.



### Measures 3:

#### Bottom-up Involvement of the Ukrainian Diaspora

Strengthen Ukrainian diaspora organisations to support the integration of displaced persons and promote social cohesion.

Key actions include research on diaspora engagement strategies, capacity-building workshops and establishing a digital platform for mobilising diaspora resources.



### Measure 4:

#### Support for Migration Management in Ukraine

Focus on improving migration management in the area of asylum procedure and irregular migration, developing a new migration framework and support to institutional capacity building.

## BENEFICIARIES



### DISPLACED UKRAINIANS

Primary beneficiaries, particularly vulnerable groups such as single parents, the elderly and individuals with disabilities, will receive legal and social support through advisory services.



### UKRAINIAN DIASPORA

Diaspora organisations will benefit from capacity-building efforts to help integrate displaced persons and prepare them for reintegration in Ukraine.



### UKRAINIAN INSTITUTIONS

Government agencies involved in migration management will benefit from training, technical assistance and alignment with EU standards.
