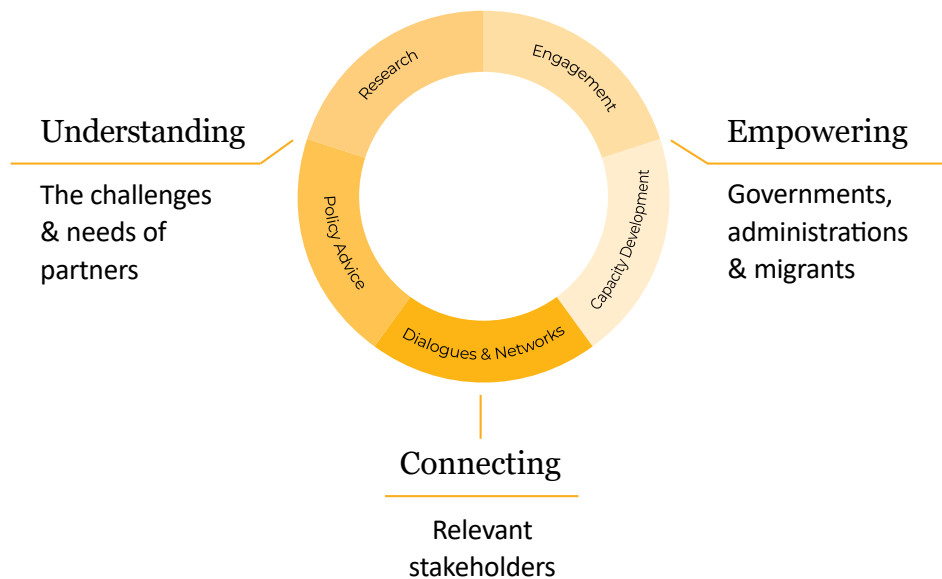
Effective migration management is a fundamental requirement for stability, security and human dignity. At ICMPD, we take a whole-of-route approach.
